#### 4. Agency Updates:

### The National Science Foundation (NSF):

NSF continues to expand support in Research.gov, many NSF funding opportunities are supported in Research.gov and clearly specify whether submission via Research.gov is available or required. Always be sure to check the funding opportunity guidelines to see if a specific submission portal is required. A full transition is expected from FastLane to Research.gov by a target date of 12/31/22. Other features include:

- a. Proposal landing page in research.gov updated with a proposal set-up wizard to start new proposals
- b. New compliance checks
- c. New FAQs are available About Proposal Preparation and Submission

PAPPG 22-1 is effective for proposals submitted or due on or after October 4 <u>https://www.nsf.gov/pubs/policydocs/pappg22\_1/nsf22\_1.pdf</u>

NSF has incorporated trimming functionality in FastLane and Grants.gov for Current and Pending documents. This functionality will be integrated in Research.gov on October 4. This functionality will remove blank pages from the NSF-approved current and pending support fillable PDF. Just as an FYI, the page numbers will not be updated when a page is trimmed and Program Officers are aware of this.

Updated NSF biosketch and current and pending documents are required beginning on October 4. They are available now for preview.
