**Most federal applications now require the UEI instead of the DUNS.**

Any subrecipients named in a proposal need to obtain a UEI in SAM.gov, although they don't need to be registered in SAM.gov to do this.

#### **3. Research.gov vs. FastLane**

Check the funding opportunity guidelines to see whether a proposal should be initiated in Research.gov or FastLane. Some opportunities are limited to one or the other. When in doubt, use whichever one the PI is most comfortable with. If there is a Lead collaborator working with non-lead collaborators, use the portal that the lead is using.
